## CALL FOR CONTRIBUTIONS FOR THE INTERNATIONAL CONFERENCE

The Emerging Professionals Working Group (EPWG) of the German National Committee of the International Council on Monuments and Sites (ICOMOS), in collaboration with ICOMOS Kazakhstan, is pleased to announce a dual event: a **conference**, *Global Dissonant Modernities: Designing the Future for 20th-Century Architectural Monuments and Sites*, and a **summer school**, to be held in Almaty, Kazakhstan, between **17 - 21 August 2026**.

The event is conceived as a platform for mutual exchange between theoretical and practice-based knowledge, bringing together colleagues from Kazakhstan and the international heritage community, while fostering dialogue between established professionals and emerging professionals. Through this exchange, the summer school and conference aim to create a space for shared learning, critical reflection, and the transfer of experience across geographical and generational contexts.

Kazakhstan presents a particularly outstanding opportunity for this exchange. As a relatively young independent state, its legal and institutional frameworks for heritage protection have not yet fully integrated modern architecture. This has led to rapid and often contradictory urban transformations, sparking debate among professionals, policymakers, and the public alike. Rather than framing these conditions as a deficit, the conference and summer school approach them as an opportunity for dialogue, comparative learning, and the co-production of knowledge across local and international perspectives.

## Conference Themes and Panels

We invite paper and presentation proposals addressing one or more of the following panels:

### **Panel 1: Defining Significance – From Terminology to Values and Law**

This panel addresses how 20th-century heritage has been defined, valued, and legally recognised. Contributions may explore terminology, international and regional legal frameworks, and criteria for assessing the significance of more recent heritage, reuse potential, and long-term stewardship.

### **Panel 2: The Dissonance of the 20th-Century – Beyond Architectural Canons**

This panel examines the political, ideological, and material dissonances surrounding 20th-century architecture. By engaging with architectural semiotics, the panel will examine how shifting sign values complicate contested histories and contribute to public resistance to preservation. Papers may address the fluidity of meaning, societal perceptions, ideological legacies, and conservation challenges.

### **Panel 3: Methodology and Capacity Building**

Focusing on knowledge transfer across regions and generations, this panel explores methodological approaches, heritage education and dissemination, and capacity building in the conservation of 20th-century heritage. Contributions may address pedagogical models, East–West exchanges, digital tools supporting collaborative heritage practice, and ethical decision-making in reuse processes.

### **Panel 4: Conservation in Practice – The "Living Laboratory"**

This panel focuses on applied conservation strategies through case studies, with a particular emphasis on buildings that remain in active use. Contributions may explore reuse-led approaches that examine environmental sustainability and responsible future use, institutional memory, hidden building histories, material ageing and current state, and practice-based learning through conservation projects.
